# NOTICE OF UNCONTESTED ELECTION

On Thursday 4<sup>th</sup> April the Returning Officer from Wychavon District Council announced the list of uncontested Parish and District Councils.

It was confirmed that there will **NOT** be an election on 2<sup>nd</sup> May 2019, as all seats were uncontested. The newly elected Council will take up office on Tuesday 7<sup>th</sup> May. The Parish Council intend to co-opt to fill the vacant seat at their AGM on Tuesday 14<sup>th</sup> May.
