PARISH COUNCIL UPDATES:

Property Marking & Defibrillator Training

Your local Safer Neighbourhood Team, from West Mercia Police, in conjunction with the Parish Council, will be holding a Property Marking Event on Sunday 16th June 2019 between 10 – 1pm at COOKHILL VILLAGE HALL.

Appointment of New Council – The newly elected Cookhill Parish Council met for the first time following the uncontested elections on May 2nd. The Council re-appointed Cllr Pinfield as Chair and Cllr Sumner as Vice Chair. They co-opted to fill the vacant seat and now have a full council.

<u>Annual Return</u> - The Parish Council approved the annual accounts for 2018/19 ready for the annual audit. The end of year accounts have been reviewed by the internal auditor and will be available to view, by appointment only, from Monday 17th June until Friday 26th July.

Cookhill Village Hall Kitchen Renovations Party

are due to be finished by the end of May. The Hall remains open during the works. There will be a celebratory party on **Saturday 15th June** to give people a chance to see the new bar and kitchen.
