PARISH COUNCIL UPDATES:

Cookhill Allotment Update – The Cookhill Allotment Association have reported that the site is looking good with tenants planting up their crops for the year. The equipment purchased, with funding from the Parish Council, is being well used. There are no vacant allotments, with all 34 plots occupied.

Cookhill Village Hall Renovations – The kitchen & bar renovations are now complete at the Village Hall. The Parish Council thanked the committee, on behalf of the community, for their hard work and determination in overseeing this huge project.
