### **Race Night at Cookhill Village Hall – POSTPONED**

The Village Hall Race Night, scheduled for 20<sup>th</sup> July, has been postponed.

**Dog Poo!** – Dog poo continues to be a serious problem along Cookhill footpaths. The Parish Council aim to keep paths strimmed to enable walkers to enjoy the countryside, but with hidden poo in the long grass this has proved to be a disgusting, and totally avoidable, problem for the Lengthsman.

***If dog walkers don't pick up after their dogs then the Parish Council will have no choice but to leave some paths to become overgrown!***

### **SmartWater – We Don't Buy Crime**

Rachael Oakley, a representative from the SmartWater & West Mercia Police team, joined the Parish Council this month to talk about the use of SmartWater as a deterrent to criminals. She explained how marking your property with SmartWater works and how it helps to track items back to you, and to the person who stole them!

The Parish Council would need an 80% take up from Cookhill residents to entitle them to funding of 25% from the Police & Crime Commissioner. They will be debating this at the next meeting on 13<sup>th</sup> August. Please come along if you would like to air your views!
