#### **PARISH COUNCIL UPDATES:**

#### **Cookhill Allotment Update**

**Public Liability Insurance** – Following research into the necessity for having PLI for the Cookhill Allotments it was agreed that the Parish Council would take out a policy covering each tenant on their plot and working elsewhere onsite, including help with bonfires and strimming.

**Strimmer Purchase** – It was agreed that an extra strimmer was required at the allotments and one will be purchased for use there.

**Plot availability** – There is currently 1 plot available at the popular Cookhill Allotments site.

#### Lengthsman & Parish Paths Update

The Lengthsman has trimmed the hedges at the Playing Fields and carried out essential work to clear gullies. Footpaths are kept strimmed each week.

Fallen Tree – A tree blocking the path was reported to the Parish Council, along the footpath heading from Evesham Road towards Knowle Fields. The Parish Paths Warden has agreed to investigate.

<u>Signage on the Salt Way</u> – County Clir Hopkins advised that the missing signage at the bottom of Edgioake Lane and at the top of the Salt Way, by the Nevill Arms, was being treated as a matter of priority and would be replaced very soon.

Consultation ended 29<sup>th</sup> August the Parish Council recommended APPROVAL.

W/19/01926/TDC5 Field adjacent to 45 The Ridgeway, New End, Astwood Bank

**Proposal:** Application for technical details (part 2) following approval of Permission in Principle Ref 18/02276/PIP for a rural exception development consisting of the erection of 3 no. affordable self-build dwellings.

Recommendation: The Parish Council recommended APPROVAL.
