PARISH COUNCIL UPDATES:

Happy New Year from Cookhill Parish Council!
Edgioake Lane / Salt Way Signage — The replacement signs missing at the junction with Edgioake Lane and the Salt Way are being chased with some urgency following another collision on the junction over Christmas. The signs at the top of the Salt Way will be replaced soon.

<u>Cookhill Allotment Update</u> – Unprecedented wet weather has meant that tenants have been unable to get on the site to start work on their plots. Work will be carried out to create a ramp into the new container and also to renew the entrance track. There is currently 1 plot available at the popular allotments site.
