- 17.142. Planning Matters:- members of the public were invited to speak on the applications notified to the Parish Council.

    - a. W/17/02246/HP 29 Oak Tree Lane, Cookhill, B49 5LH

**Proposal:** Erection of a double brick wall, to a height of 1.9 metres, plus one set of gates, to the boundary of the property.

Consultation ended: 1st December 2017, the Parish Council recommended REFUSAL

- b. APP/H1840/W/17/3183049 7 The Ridgeway, Astwood Bank, Redditch, B96 6LS
  - **Proposal:** Subdivision of garden to No.7 The Ridgeway and a new detached zero carbon dwelling with associated landscaping. APPEAL.
- c. Pre Application Enquiry for the proposed telecommunications radio base station installation at Oaks Barn Farm, Knowle Fields, of A422, B49 5LS Not received via Wychavon Planning.

The Council recommended contact with the Planning Department before making comment.

**Proposal:** Retrospective application for 2 storey rear extension to create lounge extension and extra bedroom at No.6 & No.8 Church Lane

Decision: APPROVED 23<sup>rd</sup> November 2017

- iii) Planning enforcement matters from Wychavon Planning: None reported
- 17.143 VAS on Edgioake Lane A quote for a solar powered VAS has been received from Unipart Dorman. A post has already been installed by Highways on Edgioake Lane but is not of a sufficient size for the required sign. Cllr Hopkins said that he would investigate a possible grant to fund a larger post as the Highways Department are unable to fund this. He also agreed to speak to Highways about locating a contractor to install the new post. It was agreed unanimously that the VAS would be purchased, as per the agreed 2017/18 budget, and it will be installed in the New Year. Payment will be raised at the January meeting.

#### 17.144. Finance

- The monthly statement and bank reconciliation for November 2017 showing the available funds, the income and expenditure comparison to the budget was approved.
   Cheques for payment were presented, approved and authorised for payment.
- b) **Mobile Phone Upgrade** The Chairman asked the Council for their thoughts on upgrading the clerk's mobile to enable her to access emails and the internet from her phone when out and about. This was proposed by Cllr Sumner and seconded by Cllr Draper. This was agreed unanimously.
- c) **BT Broadband price increase** The clerk reported that the Broadband service with BT had been upgraded to a faster speed and had been secured at just a £2.50 increase. The amount of £31.99 will be taken from the bank account automatically by direct debit. This increase was agreed unanimously by the Parish Council.
- d) Village Hall Mulled Wine Evening The £250 grant towards the free Mulled Wine & Mince Pie evening proposed by Cllr Pinfield and seconded by Cllr Draper.
- e) Budget & Precept The amended figures were approved and will be set at January's meeting.
