- **18.033. Minutes:** The Minutes of the meeting of the Council Tuesday 13th March 2018 were approved by the Council and signed by the Chairman. Proposed by Cllr Davis and seconded by Cllr Churchill.

18.034. Police and Neighbourhood Watch Reports

- Police Reports A number of incidents had been reported to the Parish Council since the last meeting. These comprised of forced entry to properties and the theft of motor vehicles and tools. Parishioners are asked to be vigilent.
- **Neighbourhood Watch** A meeting of the current committee will take place to dissolve the group and hand responsibility to the Parish Council.
- Community Speed Watch The Council are now in receipt of an in-date radar and will arrange sessions soon.
- VAS Installed on Edgioake Lane. The sign is picking cars up outside the 30mph zone. To be monitored.

18.036. Progress Reports

- a) County Cllr Anthony Hopkins:
 - VAS The post, paid for from Divisional Funds, has now been installed and the VAS is up. The Council thanked Cllr Hopkins for his help in getting this sorted.
 - Village Hall Funds have been allocated to Cookhill Village Hall towards essential maintenance. The Village Hall representative passed on the thanks of the Village Hall Committee.
 - A422 It was reported that investigation works were still ongoing along the stretch of road plagued by road traffic accidents, out of Inkberrow. It was asked whether double white lines here may reduce incidents.
- b) District Councillor Steel:
 - Wychavon Once again voted 3rd best place to live in the UK. There is a lot of work going into local towns.
 - **Inkberrow Development** All of the new houses have now been completed, with the opening planned for Saturday 2nd June giving people a chance to look round the development.
- c) District Councillor David Wilkinson: No update
- d) Chairman Cllr Pinfield:
 - Severn Trent Water Severn Trent Water are working in Cookhill to replace the water main. Works are expected to carry on for 18 months, with road closures planned.
 Disruption will be minimised. A diversion will be in place for 10 weeks whilst sections of the A441 are closed. Mr Hale from Amey, contracted by Severn Trent Water, will be available to answer questions about the works at the next Parish Council meeting on the 8th May.
 - **Verges** It was reiterated that, in most cases, the verges outside properties belong to the Highways Department and placing of objects here is an offence.
 - The verges in Oak Tree Lane were discussed and the Councillors agreed that trying to tidy up verges whilst works continue in the area was not viable. Severn Trent have assured the PC that verge damage will be rectified.
- e) Clerk's Update: Work to adopt the area of land known as Sandholes, leading to the allotments, continues.
- f) Parish Paths Warden: Apologies
- g) Cookhill Village Hall:
 - Skittles Evening Saturday 21st April. 6.30 for 7.00pm
 - Race Night Saturday 2nd June. To correspond with the Epsom Derby the Village Hall plan to serve sandwiches, strawberries and cream and cake. Anyone interested in sponsoring a race should contact the Village Hall Committee.
- h) Lengthsman Scheme: A new contract has been sent to the Lengthsman, with Mr Luke Farnsworth taking over the main role from April 2018. Work continues around the Parish as requested by the Parish Council.
- i) Playing Fields: White lines on the road to be carried out within the next month.
- j) Affordable Housing Ridgeway Meadows: There have been reports of walkers straying from the footpath across the Parish Council fields directly behind Ridgeway Meadows. The situation is in hand and will be monitored.

- b) Field Rents Rents will be reviewed in 2019 with advice being sought regarding Rural Payments.
- c) Clerk Salary The increase of the clerk's salary was agreed, to be implemented from April 2018. The Council acknowledged that a salary increase should have been awarded in 2017 and it was proposed that the clerk's salary be backdated to incorporate the increase. This was agreed unanimously.
