- 18.050. The Parish Council welcomed visitors from;

Severn Trent – Mr Mead from Severn Trent advised the meeting that the works to replace the water main along the length of Cookhill is scheduled for completion in May 2019. Sections of the A441 will be closed commencing Tuesday 29<sup>th</sup> May for approximately 6 to 8 weeks with access to frontages. These closures will end at the Village Hall.

The Game Fair, Ragley Hall – Ms Johnson from the Game Fair team at Ragley Hall confirmed that the dates of the fair are Friday 27<sup>th</sup> July to Sunday 29<sup>th</sup> July. There will be traffic management systems in place to minimise any disruption through Cookhill and the team will work closely with Severn Trent to ensure that any overlapping road works are removed for the weekend of the fair.

  - Verges Items placed on the verges in Oak Tree Lane are causing an obstruction. Not all landowners are the owners of the verge and a Land Registry search will confirm where a boundary ends. For next Agenda.
