Summary from the Cookhill Parish Council Meeting held virtually on Tuesday 10<sup>th</sup> November 2020

#### **PARISH COUNCIL UPDATES:**

<u>Cookhill Allotments</u> – The site has been prepared for the winter, with hedges trimmed and tracks to be given one last cut. The perimeter fencing has been repaired. Social distancing rules are being maintained and tenants can attend to their plots safely. There are currently no vacant plots at the site. ### **Parish Paths Update**

Following a request for disabled access to the public footpath on the Ridgeway, the PC are pleased to confirm that a new gate will be installed, giving access to the walk leading down to Botany Bay.

### **Lengthsman Update**

It has been confirmed that the Lengthsman can continue to carry out his duties during the current restrictions. Should urgent work be required on a footpath it will be closed to ensure adequate social distancing can be maintained.

### **Cookhill Village Hall Update**

The Village Hall remains closed during the current lockdown period. The hall is checked on a regular basis, as instructed by their insurance company.

### **Defibrillators**

The battery in the defibrillator at SE Davis has been changed. All the pads have been checked and replaced, where necessary. A regular check of the equipment will be maintained throughout the year.

# Cookhill Playground & Adult Exercise Equipment

The playground remains open during the current lockdown restrictions, in line with Government guidelines. The Parish Council continue to monitor the usage and conduct at the park. The equipment is cleaned thoroughly twice a month.

The issue of speeding on the Salt Way is still under investigation, with a request from County Cllr Anthony Hopkins for a speed survey to be carried out in this location.
