- a) County Cllr Anthony Hopkins:
 - Signage The missing signage at the bottom of Edgioake Lane has been replaced. The issue of the missing signage at top of the Salt Way is being chased with some urgency.
 - Flooding The water leak at top of Edgioake Lane has been resolved with Severn Trent
 - Potholes Potholes on the main road by Dogbut Lane have been reported for repair.
 - Speed Vans The speed van has still been active in Cookhill. Cllr
 - Budget There will be a 3.99% increase. 2% adult social care. The rest will also go to schools and children's services and highways.
- b) District Councillor Steel:
 - New Managing Director for Wychavon Interviews being conducted.
- c) District Councillor David Wilkinson: Apologies
- d) Chairman Cllr Pinfield:
 - Ditches & Flooding on Edgioake Lane It was recommended that Wychavon contact any landowners on Edgioake Lane who have not cleared their ditches. There has been a very positive response from landowners clearing their ditches.

 - Noticeboard at Ridgeway Meadows To be repaired
- f) Parish Paths Warden: Apologies
- g) Cookhill Village Hall: Apologies
- h) Lengthsman Scheme: Verge repaired at the top of Alcester Heath where a HGV had gone straight the crossroads. Work is continuing on the siding out of the footpath from the Village Hall to the Nevill Arms.
- i) Playing Fields: No update
- j) Affordable Housing Ridgeway Meadows: Storm damage to property. Following contact with the homeowner's insurance company Rooftop Housing have agreed to send an officer out to inspect the damage and organise
- k) Cookhill Allotments:
 - 3 vacant plots
 - New mower To be delivered in March with the invoice coming to the Parish Council.
 - Containers Tenants to paint the containers when the weather improves.
 - Hardcore Hardcore will be delivered
 - Posts to be installed The damaged posts due for replacement by plot 1 to be chased.
 - Locks & Chains New locks under investigation. Update from Cllr Davis.
- 20.018. Inkberrow Charitable Trust Update Two new accounts have been opened for the Trust with Triodos Bank, one for Cookhill and one for Inkberrow which will contain the interest from the main funds. Funds will be allocated as soon as the cheque has been paid in. The Charities Commission are still awaiting the audited documents.
- **20.019. Electric Car Charging Points** The possibility of installing electric car charging points in Cookhill was discussed. Grants are available to install the points. Chris Brookes from Wychavon can provide further information.
- 20.020. The following purchases were agreed;
 - Bus Shelter for Church Lane It was agreed that the current bus shelter be replaced with a 3 bay shelter subject to
 installation charges. This will be put on the March Agenda for approval.
 - Replacement Defibrillator Unit The unit at the Nevill Arms is not working and is now out of guarantee. A different style
 cabinet was recommended for the replacement. Proposed by Cllr Bennett and agreed unanimously.
- 20.021. Finance
 - a) The monthly statement and bank reconciliation for January 2020 showing the available funds, the income and expenditure comparison to the budget was approved.
 Cheques for payment were presented, approved and authorised for payment.
