PARISH COUNCIL UPDATES:

<u>Cookhill Allotments</u> – The drainage work at the allotments is due to start soon, but is weather dependent. The equipment has been delivered in preparation. The plots are due to be renumbered, using custom made metal number plates, over the autumn. Weed-killing will be undertaken before winter.

Proposed: Demolition of existing conservatory; erection of new single storey rear extension *The Parish Council recommended that the application be APPROVED.*

W/21/01533/CU Oaks Barn Farm, Worcester Road, Knowle Fields, Cookhill, B49 5LS *Proposed:* Change of use of the existing agricultural barn to allow it to be used as a wedding / function venue between the months of April to October annually, with agricultural use resuming November to March and use of the adjacent pasture land as a car parking area. *The Parish Council recommended that the application be REFUSED.*
