<u>Community Speed Watch</u> - The Community Speed Watch Team are looking to recruit new members. Volunteers will receive specialist training to use the equipment in Droitwich. <u>Severn Trent Water</u> – The essential maintenance at the Cookhill site continues, with tankers accessing the location via Lower Cladswell Lane several times a day. Severn Trent apologise for any inconvenience caused during this time. Further road closures in Cladswell Lane are scheduled for the end of September, the road will be closed for 19 days.

#### Parish Paths / Lengthsman

- A new dog waste bin has been installed on Mearse Lane.
- The footpath from the Village Hall to the Nevill Arms has now been sided out by the Lengthsman, giving pedestrians more space to pass safely by this busy road.
- The kissing gate on the path by the allotments has been repaired following concerns that livestock may get out.
