Lengthsman / Parish Paths

The Lengthsman has been carrying out essential work to clear drains, ditches and gullies around the Parish. New footpath signs have been installed. The Parish Council intend to register the unmarked footpath from the Ridgeway to their fields. The flooding on the A441 has been reported to the County Council Highways department. The blocked gully under the road is the main problem.

<u>**Planning:**</u> the Parish Council has asked Wychavon District Council (WDC) to send notification to us of all planning applications that fall within the parish boundary, these are then discussed at a parish council meeting and the ensuing comments are submitted to WDC.
