#### Code of Conduct

#### Plant a Tree for the Jubilee

The Parish Council have voted to call the new meadow behind the houses at Ridgeway Meadows, Platinum Meadows. The Council have applied to Fields in Trust to have the land legally protected as an open space in perpetuity.

The new trees, planted behind Ridgeway Meadows in March, are growing well with a new boundary fence now installed. A small number of volunteers from the Allotment Association

will be strimming the grass and mulching between the trees on Saturday 18<sup>th</sup> June. The Parish Council wished to extend their thanks to David Claydon, and the volunteers, for all their help with the project so far.

#### 'Twenty is Plenty' Campaign

It was proposed to vote in support of normalising 20mph where people live, shop, work, learn and play, in place of the outdated 30mph. This proposal would reduce casualties by 69 per year. The authorities of 28 million people in the UK have already agreed this policy.

<u>Planning</u>: the Parish Council has asked Wychavon District Council (WDC) to send notification to us of all planning applications that fall within the parish boundary, these are then discussed at a parish council meeting and the ensuing comments are submitted to WDC. Decision: The Parish Council recommended that the application be APPROVED.

**Proposed:** Demolition of conservatory and erection of two storey side and rear extension, porch and alterations to elevations.
