

The Minutes of the Cookhill Parish Council Meeting Held on Tuesday 9th January 2024 at 7pm SE Davis Meeting Room, Sandhills Farm, Edgioake Lane, B96 6BG

- b) District Councillor Update: Apologies. Report received.
 - Community Legacy Grant The Wychavon community legacy grant opened on 8th January. If there are any
 projects the parish council are keen to get off the ground this may be worth looking at. The grant is aimed at
 innovative, ambitious capital projects that will benefit the community. All details are on the Wychavon
 website as of 9th January.
 - Trees Call to Action Project Heart of England Forest are promoting a new initiative for community orchard
 projects. The Trees Call to Action Project (TCAP), along with Wychavon and the UK Shared Prosperity Fund
 partnered with Heart of England Forest, are offering schools and community groups the opportunity to
 access trees to plant an orchard.
- Chairman's Update: Updated VAS proposed for the Salt Way to replace the old sign following continuing reports of speeding in this area.
- d) The Clerk provided an update on the following:
 - Water Leak The owner of the house has been contacted and he says it is a natural spring causing the problem. The PROW Team are investigating a solution. Ongoing.
 - Notice Board at SE Davis The notice board that was damaged during the installation of the new entrance still needs repair or replacement. Prices to be investigated.
- e) Parish Paths Warden: Nothing much to report since the New Year. The water leak onto the footpath (mentioned above) was
- f) Cookhill Village Hall: Please contact the Village Hall if you can offer any assistance with events.

- g) Lengthsman Scheme: The new Parish Lengthsman has been carrying out necessary work in the parish and has cleaned the road signs.
- h) Playing Fields: The goals will be moved and the hedge assessed as it will need to be cut back soon.
- i) Cookhill Allotments / Parish Land: Report from Mr David Claydon, Cookhill Allotment Association Chairman;
 - Plots There are currently three allotment plots available. Tenants have been asked to let the committee know if they
 intend to give up their plot before the spring invoices are sent out.
 - Weather conditions Following the heavy rain of the last few months the inner track has recovered well following the additional drainage works. Tenants have been reminded to take advantage of any dry spells over the coming months to turn over their plots and add some compost or manure.
 - Servicing The sit on mower and the two strimmers will be serviced during January / February.
 - Hedge Trimming The allotment and field hedges have now been trimmed.
